the above-named licensee ("Licensee"), the non-exclusive right to reprint or otherwise reproduce certain copyrighted materials held by the Licensor, to the extent of and under the following conditions and restrictions:

1. **Reprint rights:** This license allows the reprinting of (a) only the **melody line and words** of music solely for **use by a congregation**, including hymns, songs, refrains, and/or the parts for congregation only in settings of the Mass Ordinary and other service music for which the Licensor holds copyright or licensing rights, as well as (b) text materials such as articles, reflections prayers, and the like. Permission is granted for congregational purposes (i.e., song sheets, bulletin inserts, PowerPoint® projection, seasonal worship programs, bulletins, newsletters, etc). Any and all such reprinting must be reported in accordance with the provisions of Paragraph 8 of this license.

2. **Mechanical rights:** This license also allows (a) the use of the **text and melody line** in cantor/choral practice sound recordings made by the Licensee specifically and for the sole purpose of cantor/choral practice. The sound recording may be on compact disc or cassette. Such cantor/choral practice sound recordings may not be sold or given away on a permanent basis; such recordings are solely intended to be used for purposes of practice and returned to the Licensee. This license also allows (b) the recording of the Licensor's copyrighted material as an integral component of the electronic use rights, described below. Any and all such recording must be reported in accordance with the provisions of Paragraph 8 of this license.

3. **Electronic rights:** Electronic rights are granted solely for use on the Licensee's website, as listed above. Such rights include the right to use the Licensor's copyrighted material, as described herein, for non-commercial purposes, as follows: (a) display/post, or stream the Licensee's recordings of the Licensor's copyrighted songs, (b) create and make available podcasts, and (c) post demo practice recordings for the Licensee's cantors or choir, the limits upon which are more fully described above. Any and all such use must be reported in accordance with the provisions of Paragraph 8 of this license. For purposes of reporting a posted item, a week of website posting constitutes one reportable use, and each week of posting must be reported.

4. All of the reprinting/reproductions permitted under Paragraphs 1, 2 and 3, above, are collectively called the "Copies".

5. **THIS LICENSE SPECIFICALLY EXCLUDES THE FOLLOWING:**

a. The right to reprint any of the Licensor's copyrighted material in a custom made permanent hymnal or permanent songbook.

b. The right to use any of the Licensor's sound recordings in any manner.

c. The right to make sound recordings of any of the Licensor's copyrighted materials, except as described above. For any sound recordings other than practice-related recordings, a separate Mechanical License must be obtained from the Licensor.

d. The right to link to a website other than as set forth above and make available any of the rights or privileges granted herein.

e. The right to create and play a video containing sound recordings of copyrighted material of the Licensor, for which a separate license must be obtained. Subject to the foregoing, it is the Licensor's established policy to grant broadcast/synchronization rights, free of charge and without the need for a separate license, for the use of music, owned or administered by the Licensor, in the celebration of Sacred Liturgy.

f. The right to reprint choir parts of any kind, cantor or choir verses to music intended for alternation between cantor or choir and congregation, accompaniments of any kind, including guitar or keyboard chord symbols, and any other material that would reduce the necessity for the choir, cantor, or accompanists to use commercial publications of the Licensor to fulfill their music ministries.

6. The following must be reproduced exactly on each of the Copies, including website posting: the complete title of the reprinted/reproduced item; the names of the composer(s), author(s), arranger(s) and translator(s); and, the copyright notice, as more fully described below. The **name(s) of the composer(s) must appear on words-only reproductions** since the music will be sung.

7. The copyright notice for each item reprinted/reproduced must appear on the same page as the title of the item, or appropriately and conspicuously displayed on the Licensee's website, and must include the following: the word "Copyright"; the international copyright symbol ©; the year of the copyright, followed by the name of the Licensor or copyright owner; the phrase "All rights reserved"; and the phrase "Used by permission under license number (assigned License Number). **Example:**

8. Each and every time an item is reproduced under Paragraphs 1, 2, or 3 of this license, the Licensee must complete and submit to the Licensor a Usage Report (a copy of which is attached to this Agreement) listing all titles, composer/author's name and date(s) of use. Multiple uses of one item for the Sunday liturgies over an entire weekend constitute one reportable use. For Mass settings, the name of the Mass and each individual part must be specified (i.e. Mass of Redemption – Memorial Acclamation A). Usage Reports may be submitted weekly or monthly by clicking the reprint and permissions tab at the Licensor's website: wlpmusic.com. Usage Reports may also be submitted by e-mail to WLPReprint@jspaluch.com, and if by regular mail, to the attention of the Permissions Department.

9. This license shall expire exactly one (1) year from the statement date on which this license was billed ("Expiration Date"). On the Expiration Date, all Copies of any and all items reproduced by any means under the terms of this license, including electronic storage or website usage and display, must be destroyed or removed unless a renewal of this license has been obtained by payment of the appropriate fee invoiced to the Licensee, and in such case, the renewal will be effective as of the Expiration Date. After the Expiration Date, this license may only be cancelled by the Licensee within thirty (30) days after receipt of the invoiced statement for renewal of this annual license. No cancellation or refund request will be honored after such thirty (30) day period.

10. No rights other than those specifically granted under this license are granted or implied. This is not a license to broadcast or record any item for which the Licensor holds the copyright, except as expressly permitted by this agreement. This license does not grant or imply any rights to reprint or reproduce the copyright holdings of any publisher other than the Licensor. Such rights must be secured from the copyright holder of the desired item. All rights and privileges granted herein extend only to the Licensee (and in the case of a diocesan office or agency, are limited to use in diocesan liturgies and diocesan events planned by such office or agency) and may not be sold, transferred, loaned, or otherwise distributed to any other individual, group, institution, entity or agency, including any diocesan agency or parish in the diocese.

11. The annual license fee, as set forth at the top of this agreement, will be billed to the Licensee by regular mail, which the Licensee agrees to pay according to the invoice terms.

12. The Licensee hereby accepts all terms and conditions of this license.
